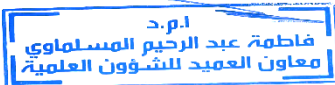

Professional Development

Mentoring new faculty members

The process of mentoring new, visiting, full-time, and part-time faculty members at the institution and department level includes several steps:

1. Provide general guidance: An introduction is provided to the mission, vision, educational and research goals of the university or educational institution, as well as the values and policies that faculty members must adhere to.
2. Specialization Orientation: New, visiting, full-time, and part-time members of each department or college are specifically guided about academic and research requirements related to their individual majors.
3. Review Policies and Procedures: New, visiting, full-time, and part-time members should review the policies and procedures of the institution or department including academic, administrative, and financial systems.

4. Resource guidance: New, visiting, full-time, and part-time members should receive guidance on the resources available to them such as libraries, laboratories, technical equipment, and technical support.
5. Training and workshops: Workshops and training programs can be organized to equip new members with the skills and tools needed to perform their work effectively, whether in teaching, research or management.
6. Technical and advisory support: Technical and advisory support is provided to new, visiting, full-time and part-time members in areas such as academic design, educational technology, and curriculum development.
7. Performance evaluation and follow-up: Periodic evaluation of the performance of faculty members is carried out and the necessary observations and guidance are provided to improve their performance, in addition to providing the necessary support for continuous professional development.

Professional development of faculty members

The professional development plan for faculty includes innovative teaching and learning strategies, and continuous evaluation of learning outcomes. Workshops and training programs are organized to develop teaching skills and the use of modern educational technologies. Technical and advisory support is also provided for curriculum design and development of educational resources. Professional development also includes participating in academic research and publishing, and contributing to undergraduate and community service activities.
