applications. In years 2 and 3 you may also take a limited number of modules delivered outside the department.

## 6. Credits, Grading and GPA

### Credits

(Name) University is following the Bologna process with European Credite Transder System (ECTS). The total degree program number of ECTS is 240, 30 ECTS per semester. 1 ECTS is equivalent to 25 hrs student workload, including structured and unstructured workload.

### Grading

Before the evaluation, the results are divided into two subgroup: pass and fail. Therefore, the results are independent of the students who failed a course. The grading system is defined as follows:

### Calculation of the Cumulative Grade Point Average (CGPA)

1. The CGPA is calculated by the summation of each module score multiplied by its ECTS, all are divided by the program total ECTS.

CGPA of a 4-year B.Sc. degrees:

$$CGPA = [(1^{st} \text{ Module score} \times ECTS) + (2^{nd} \text{ Module score} \times ECTS) + \dots] / 240$$
